Agenda	<p>This 3-day Staff Week offers a dedicated space for academic staff from SEA-EU partner institutions to explore, discuss, and co-develop approaches to qualitative research in the fields of management and accounting. qualitative inquiry in academic practice across the alliance.</p> <p>Over three days, participants will engage in a range of interactive sessions, academic discussions, and networking opportunities. The program is designed not only to build technical and theoretical understanding but also to enhance the capacity for collaborative research and innovation within the SEA-EU framework.</p> <p><u>Day 1</u> will begin with a welcome session and introductions, setting the stage for the week ahead. Participants will then engage in foundational discussions on qualitative research in management and accounting, with contributions from invited experts. A panel and open discussion will allow for the sharing of institutional practices and identification of common challenges and opportunities in SEA-EU universities. The day concludes with a networking dinner, reinforcing informal exchanges among participants.</p> <p><u>Day 2</u> and <u>Day 3</u> will integrate the international workshop “Crafting Qualitative Research in Management & Accounting”, providing participants with the chance to attend keynote lectures, parallel sessions, and interactive panels. These sessions are aimed at deepening understanding of qualitative methodologies and exploring their application in real-world academic contexts. The inclusion of this international workshop within the Staff Week framework offers participants an enriched experience, blending training with scholarly engagement.</p> <p>This Staff Week promotes the SEA-EU vision of transnational academic cooperation and supports the professional development of academic staff in qualitative research. It provides a unique opportunity to build long-lasting academic relationships and initiate collaborative projects that contribute to the internationalization of research and teaching practices across the alliance.</p>
